- \* The Board took no action on the agenda items for scheduling public hearings on **Sable Woods Subdivision** (**SD07-004**), **Stablegate Subdivision** (**SD01-002**), and **Archmont Knolls Phase 5** (**SD01-018**).
- \* Mr. Dennis Deeb, applicant, presented a request for extension of the final site plan approval for **Gibby's Plaza**, a 9,600 sq. ft. retail strip plaza at **175 Troy Schenectady Road**. A stenographic record of the proceedings was taken and is attached. The Board reviewed the request and granted an extension of one year, to expire on January 8, 2011, on a motion by Member Lane, seconded by Member Rosano, with a vote of 6-0. Member Nardacci abstained.
- \* Mr. Nick Costa of L. Sipperly and Associates presented concept plans for the Northern Pass Subdivision (SD07-008) at 586 Old Loudon Road and 1226 Loudon Road, and Northern Pass Mixed Use development at 1226 and 1236 Loudon Road. A stenographic record of the proceedings was taken and is attached. The subdivision includes 68 twin townhome lots and two lots for the mixed use development, which consists of an 11-unit multifamily residential building and two office buildings totaling 14,175 sq. ft. The Board requested that a full Environmental Assessment Form be submitted and that the concept plans be revised to address Town department and TDE comments. No action was taken.
- \* Mr. Tom Baird of Barton & Loguidice, Town Designated Engineers, presented an update to the Board on the review of the traffic impact study for the proposed **WalMart** at **4 Autopark Drive**. A stenographic record of the proceedings was taken and is attached. No action was taken.
